US Creating Crisis in Muslim World

Be it covertly or overtly, the United States has always been hellbent on creating crisis and havoc in the Muslim world in an attempt to offset its socio-economic and political affairs, and stoke sectarian sedition in the region.

TEHRAN - A senior Iranian military commander on Wednesday dismissed threats by the occupying regime of Israel against the Islamic Republic, saying the Zionist regime would regret any aggression.

"Zionist officials have repeatedly made threats against Iran but they know well that the payback for any attack on Iran and our response would be so massive that even its thought would haunt them (Israeli leaders) to death," Brigadier General Amir Ali Hajizadeh said.

Hajizadeh is the head of the aerospace force of the Islamic Revolution Guards Corps. He said, "The Zionist regime might be thinking of an aggression against Iran but after weighing the very serious consequences of the Islamic Republic's response, it would definitely realize that such a decision is a crude one," he said.

The occupying regime of Israel has openly threatened Iran with military strikes, citing the country's nuclear energy program as geared toward non-civilian purposes.


The Islamic Republic however has warned the Zionist regime of dire consequences of such a decision.

Saudi-Iran Ties Taking Normal Course

TEHRAN (Press TV) -- Iranian Foreign Ministry spokeswoman Marzieh Afkham says relations between Iran and Saudi Arabia are on a natural course, expressing hope for the promotion of ties between the two Middle East powers.

"In general, Iran's relations with the regional countries including Saudi Arabia are taking their normal course," Afkham said.

She pointed to the Iranian foreign ministry's plans to promote ties with Saudi Arabia. "Naturally, as Iran's new ambassador to Saudi Arabia takes office, there are some plans so that we may have a new assessment of diplomatic activities." In late June, Iran's foreign ministry announced the appointment of Hussein Sadeqi as Tehran's new ambassador to Riyadh.

"We are optimistic that a new climate will prevail regarding (ties with) Saudi Arabia within the framework of relations with other regional countries," Afkham pointed out.

On Sunday, Saudi Arabia's Foreign Minister Saud al-Faisal voiced his country's readiness to improve and expand bilateral relations with Iran.

The two key Middle East players are livided on a number of regional issues such as the situation in Syria and Bahrain Tehran has always been critical

of Riyadh's support for the heavyhanded crackdown of the Bahraini regime on peaceful protesters.

Riyadh also supports militants fighting the Syrian government, while Iran stresses the importance of resolving the crisis in Syria through political approaches.

U.S. Concealing Ties With Anti-Iran Group

WASHINGTON (Dispatches) -- The U.S. government has launched rare legal efforts to avoid the potential exposure of its dealings with a U.S.-based anti-Iran group that has been embroiled in a defamation lawsuit.

The so-called United Against Nuclear Iran, a non-governmental lobbying group that has been campaigning against Iran's peaceful nuclear activities, has recently come under spotlight for its access to secret U.S. government files, The New York Times reported.

The allegation of the group's access to such files was raised in the course of a defamation lawsuit filed by Greek Businessman Victor Restis against the anti-Iran group. United Against Nuclear Iran previously accused Restis' firm of doing business with Iran in violation of the illegal U.S. sanctions on the country.

"The group has undertaken several such 'name and shame' campaigns against companies around the world," according to the report. In turn, Restis has drawn billionaire "Thomas S. Kaplan into the case, asking a federal judge to order him to turn over documents that he (Restis) suspects are related to the case."

In late July, the U.S. government moved to temporarily block the files of the anti-Iran group, "including its emails and donor lists," in a highly unusual move that virtually confirmed the allegation that the group has access to U.S. government files.

"It is not clear how the group obtained the documents," the report said, adding that U.S. Justice Department lawyers are now "quietly" seeking to mediate a settlement in the defamation lawsuit that has been filed against the anti-Iran group.

"The Justice Department is concerned enough about their (the documents') release that government lawyers are quietly mediating settlement talks to try to end the lawsuit," the report read.

Restis' lawyers say the Justice Department's "unexpected involvement raises questions about the relationship between the American government and United Against Nuclear Iran."

The U.S. and some of their allies have accused Iran of pursuing non-civilian objectives in its nuclear energy program. Iran rejects the allegations, and has been involved in negotiations with the five permanent members of the UN Security Council plus Germany over its peaceful nuclear activities. The U.S. and the European Union (EU) have imposed unilateral sanctions on the Islamic Republic over the allegation, seeking to block foreign companies from doing legitimate business with Iran.
