Palestinian Prisoners' Day

April 17 marked the Palestinian Prisoners' Day. It also marked the Zionist regime's never-ending abusive treatment of hundreds of Palestinian children still locked up in Israeli jails in violation of basic human rights.

As we speak, many Palestinian prisoners are still on hunger strike in protest against decades of arbitrary arrest and inhumane treatment by the regime. Approximately 6,300 Palestinians are currently held in Israeli prisons and detention centers on vague charges, including 300 children.

The UN Children's Fund (UNICEF) says children are often coerced into signing confessions in Hebrew without understanding the language or content of the statement. The most common charge for children is stone-throwing, which carries a maximum sentence of 10 to 20 years!

Such harsh sentences are used because the world community is still looking the other way. This is while this year also marks 50 years that the Palestinians have lived without freedom, equality, or basic rights. However, the mistreatment of children by the Zionist regime runs counter to international human rights law and international Humanitarian Law, which mandates that "countries have a distinct juvenile-justice system that recognizes the special status of children, protects minors from violence, and focuses on rehabilitation and reintegration."

In the prevailing environment, the conclusion has to be this: The ongoing U.S.-led war on Syria is deliberate. It is deliberately designed to change for the worse the landscape around the Palestinian people's right to freedom and self-determination. The whole idea is to keep the resistance front busy fighting America's terror proxies in Iraq and Syria. This way no one would ever care for the Palestinians and their legitimate struggle for freedom and self-determination, much less force the UN to end Tel Aviv's systematic human rights violations, including those against children.

There is no denying that the situation on the ground is getting deliberately grimmer for the Palestinians because the world body is too busy blaming the Syrian government for staged chemical attacks being carried out by America's terror proxies against the Syrian people. The world body is also too busy with President Trump's runs against North Korea to do anything that could help protect the rights of all Palestinians, much less hold Israel accountable for its violations of international law and international human rights law.

In any event, the treatment with Palestine is not acceptable. Several anti-Israel resolutions have been passed by the UN to condemn Israeli crimes in occupied Palestine, yet they have all been vetoed by Washington, adding to the pains and problems of Palestinians. This is while all of the reports published by the UN Human Rights Council, Amnesty International, and many other human rights organizations have censured Tel Aviv for its irrefutable crimes and human rights violations.

The United Nations still has some potential for valid exercise of discourse and diplomacy, and only through the implementation of such reforms will there be any hope for the Palestinian people and international peace and justice. Else, the world body will remain, as always, a silent witness and partner to the unending bloodshed and injustice across the globe, principally in occupied Palestine, Yemen, and Syria.

Iranian-Americans Challenge U.S. Travel Ban in Court

TEHRAN (Press TV) - Iranian - Americans on Tuesday set to present in-person testimonies in a case against U.S. President Donald Trump's contentious executive order banning travel from six Muslimmajority countries.

Judge Tanya S. Chutkan of the U.S. District Court in Washington, Politico news website reported.

Denouncing the U.S. travel ban as counterproductive, the plaintiffs detailed how Iranian students, medical researchers, and others could be disproportionately hurt by the measure.

"It was a dagger in my heart as someone of Iranian-American heritage," said Cyrus Mehri, a civil rights attorney who is leading the litigation. "I really saw it as a flash point for this diaspora, over half a million strong, that has done so much to contribute to this country and is now in such danger of being potential scapegoats."

Most of the plaintiffs said were using pseudonyms in their court papers amid fears of reprisal from the U.S. administration.

Iran to Deploy 20,000 Police on Election Day

TEHRAN (Dispatches) – Twentythousand Iranian special police forces will be providing security on the day of the presidential election in Iran, a police commander has announced.

Hossein Karami, the commander of the special units of the Iranian police force, said that efforts had long been underway to ensure that the May 19 polls would be held in an "atmosphere of security and order."

To that end, 20,000 special police

forces would be deployed across the country on election day, according to Karami.

He said the base's capacity in terms of personnel and matériel had been expanded threefold as part of the efforts to provide security on election day.

Iran will be holding its 12th presidential election on May 19. Elections for the 5th city and village councils will also be held on the same day.

Press Dige Election Dialog

On April 7, the United States launched 59 Tomahawk cruise missiles at the Syrian military airfield in Shayrat near the city of Homs.

Donald Trump said the attack was a response to the alleged chemical weapon use in Syria's Idlib on April 4, which Washington blames on the Syrian government.
