'Iran Expo 2024' to Host Over 2,900 Foreign Businesspersons



TEHRAN – An official at the Iran Chamber of Commerce, Industries, Mines and Agriculture (ICCIMA) said 3,000 foreign traders and merchants will participate in the 6th International Export Potential Exhibition of the Islamic Republic of Iran, dubbed "Iran Expo 2024".

The exhibition will be inaugurated on April 27 and run through May 1, 2024, the deputy Chairman of ICCIMA for commissions, assemblies and councils affairs stated in a meeting held with the participation of representatives of the joint chamber of commerce.

TEHRAN – Director General of the West Asia Office of the Trade Promotion Organization of Iran (TPOI) Abdolamir Rabihavi said that his country is planning to export \$500 million of products to Syria in the next Iranian calendar year (to start March 21, 2024).

FAA Investigates United Boeing 737 Flight Missing Panel

Washington (Reuters) - The U.S. Federal Aviation Administration is investigating how a United Airlines Boeing 737-800 lost an external panel before landing safely in Oregon.

United Flight 433 landed at Medford Airport around 1:45 pm PDT (2045 GMT) carrying 139 passengers and six crew after departing from San Francisco, the FAA and airline said. The FAA said a post-landing airline inspection of the 25-year-old airplane revealed a missing panel. United said it will also investigate and said no emergency was declared because there was no indication of the damage during flight.

"We'll conduct a thorough examination of the plane and perform all the needed repairs before it returns to service," the airline said in a statement.

Boeing did not comment, directing questions to United Airlines. According to FAA

records, the plane was built in



late 1998.

The Rogue Valley Times posted a dramatic photo of the airplane with the missing panel. Traffic was briefly halted at the airport to search for the panel.

In the aftermath of an Alaska Airlines Boeing 737 MAX 9 mid-air emergency prompted by a door plug blowout, U.S. aviation incidents are getting more attention.

Boeing has been under heavy regulatory scrutiny following

the Jan 5 Alaska Airlines incident, with probes into the company's safety and quality standards in its production process.

Last week a United Airlinesoperated Boeing 737 MAX rolled onto the grass and off the runway in Houston, prompting investigations.

Also last week a United-operated Boeing 777-200 bound for Japan lost a tire after take-off from San Francisco and was diverted to Los Angeles where it landed safely.

Oil Prices Jump After Ukraine Strikes Russian Oil Refineries

NEW YORK (CNBC) - Crude oil futures jumped Wednesday after Ukraine struck refineries in Russia, underlining risks to production and fuel supplies from the war in Eastern Europe.

The West Texas Intermediate contract for April gained \$2.16, or 2.78%, to settle at \$79.72 a barrel. The Brent contract for May added \$2.11, or 2.58%, to settle at \$84.03 a barrel.

Ukrainian drones hit a Rosneft refinery in the Ryazan region about 130 miles from Moscow and the Novoshakhtinsk refinery in the Rostov region, according to Reuters. The strikes came one

day after Ukraine hit a Lukoil

refinery in Nizhny Novgorod, about 265 miles from Moscow.

Ukraine has repeatedly struck Russian oil infrastructure since January in a campaign to hurt the country's economy. The latest attacks come ahead of Russia's presidential election this weekend.

The targets this week are major refineries, particularly the Rosneft facility in Ryazan, which has a refining capacity of 340,000 barrels per day, according to Andy Lipow, president of Lipow Oil Associates.

ing to Andy Lipow, president of Lipow Oil Associates. The campaign of Ukrainian attacks this year has hit refineries

representing 25% of Russia's to-

tal refining capacity of 6.8 million barrels per day, according to Lipow. About 50% of Russia's refining capacity is within range of a Ukrainian drone attack, he said.

The attacks will curtail Russian diesel exports and turn the country into a gasoline importer, he said.

"We're seeing oil prices rise, really being led by products on the back of these attacks which have been going on with some regularity since January," Lipow said. "The market is pricing in higher and higher probabilities of supply disruptions especially when you damage refineries."
