Time to End Israel, Not **Just Its Terrorism**

It seems terrorism is raising its ugly head these days in various parts of the world.

While Iran is the main victim of the US, whose various forms of terrorism ranging from economic and political to media and military, has continued for the past 44 years, the Palestinians have remained the perpetual target of Zionist terrorism for more than 75 years – even before the illegitimate birth of Israel.

With the approval of the godfather of all terrorism, the US, the child-killing monstrous regime of Israel is having free hand for the past few days in the target killing of Palestinian activists in Gaza.

Kayhan Russia, Iran, Syria, Turkey **Hold Four-Way Talks**

MOSCOW (Dispatches) -- The foreign ministers of Turkey, Syria, Russia and Iran met in Moscow on Wednesday, in the highest-level negotiations so far on rebuilding ties between Ankara and Damascus after years of animosity during the war on Syria.

In his opening speech, Russian Foreign Minister Sergei Lavrov expressed hope that the meeting would pave the way to drafting a road map for normalizing Turkish-Syrian relations. Lavrov said he sees Moscow's task as "not only in consolidating politically the progress that has been made, but also in determining general guidelines for further movement.'

Syrian state media quoted Foreign Minister Faisal Mekdad as saying during Wednesday's meeting that Syria and Turkey "share goals and common interests." He said that "despite all the negatives over the past years," Damascus saw the talks as an opportunity "for both governments to cooperate with the help and support of our friends Russia and Iran.'

Yet Mekdad added that the Syrian government's "main goal" was to end all "illegal" military presences in the country, including that of Turkish forces.

"We will continue to demand and insist on the subject of withdrawal," he was quoted as saying.

Following a deadly earthquake in February that killed tens of thousands of people in Syria and Turkey, regional normalization with Damascus began to accelerate. In April, Moscow hosted the defense ministers of Turkey, Syria and Iran for talks that it said focused on "practical steps to strengthen security in the Syrian Arab Republic and to normalize Syrian-Turkish relations."

In a tweet, Turkish Foreign Minister Mevlut Cavusoglu said he stressed during the meeting the need for "cooperation in the fight against terrorism and working together to establish the basis for the return of Syrians."

Turkey is hosting more than 3.5 million refugees from neighboring Cavusoglu also said "taking the

political process in Syria forward and protection of Syria's territorial integrity," were the other issues discussed. NATO member Turkey has

backed political and armed opposition to Syrian President Bashar al-Assad during the 12-year war, and sent its own troops into the country's north.

Syria's northwest includes a sliver of territory held by rival militants, including hardline armed groups and takfiri factions backed by Turkey.

It was not immediately clear if the meeting produced any concrete outcomes.

Syrian and Turkish defense ministers had held talks in Moscow in December.

'U.S. Should Rather Stop Systematic **Rights Violations**

TEHRAN -- Iran on Wednesday urged the United States to focus on its own systematic violation of minority rights rather than interfering in other countries' affairs and judge their level of free speech.

Foreign Ministry spokesman Nasser Kanaani made the remarks via Twitter on Wednesday, one day after U.S. Secretary of State Antony Blinken claimed that Iranian women have "demanded their basic

freedoms be respected." Kanaani wrote, "Backing coups against popular govern-

ments, the [U.S.] regime has

always supported non-democratic establishments and nonelected governments, including the former regime of Iran, and has sacrificed freedom and fundamental rights of nations for its own illegitimate interests."

"Instead of judging other nations' freedom of expression and fundamental rights, it should better feel responsible for its international obligations as well as the systematic violation of human rights inside the U.S., especially those of minorities and people of color.

It must also refrain from inter-

fering in the internal affairs of countries in accordance with the principles of the UN Char-

Blinken made the anti-Iran comments in an address to the Freedom House 2023 Annual Awards Ceremony on Tuesday.

The United States claims to honor freedom of speech and accuses other countries of violating such an inalienable right. Analysts, however, say the regime does not tolerate dissent and discriminates against ethnic minorities, including those of African descent.

Raisi: No **Time Should** be Wasted in **Assassination Probe**

TEHRAN - President Ebrahim Raisi has called for an expeditious pursuance of Washington's 2020 assassination of senior anti-terror commanders, Lieutenant General Oassem Soleimani and Abu Mahdi al-Muhandis.

In a meeting with head of the Supreme Judicial Council in Iraq Faeq Zaidan here, Raisi said no time should be wasted in consigning the perpetrators of the atrocity to justice.

"Pursuing the case to the end will show that Iran and Iraq stop at nothing in their bid to enable administration of justice" towards those behind the assassinations, the president said.

Raisi said Iraq's resolve to address the Americans' "appalling" foul play and its efforts to consign those who had ordered, advised, and committed the atrocity, was clear to the Islamic Republic.

General Soleimani, commander of the Quds Force of Iran's Islamic Revolution Guards Corps (IRGC), Abu Mahdi al-Muhandis, the second-in-command of Iraq's Popular Mobilization Units (PMU), and their companions were assassinated in a US drone strike authorized by former U.S. President Donald Trump near Baghdad International Airport on January 3, 2020.

Both commanders were highly revered across the Middle East because of their key role in fighting the Daesh terrorist group in the region, particularly in Iraq and Syria.

For his part, the Iraqi official said the endeavor towards trial of those, who had partaken in the "terrorist crime," was one of the most important examples of Tehran and Baghdad's judicial cooperation.
