Trump's Conviction Irrelevant, We Want Real Justice

Remember Donald Trump. A dotard and a terrorist, who during his four years as the US president committed crimes against humanity both at home and abroad, including the unpardonable murder of the anti-terrorist icon, Qasim Soleimani, and his colleague in the fight against terrorism, Iraq's Abu Mahdi

President Lula: Iran an 'Important Trade Partner'

BRASILIA (Dispatches) Brazilian President Luiz Inácio Lula da Silva says Tehran should continue to be an important commercial partner for Brasília in the coming years.

"For the first time, I met with Ebrahim Raisi, the president of Iran, one of the countries that will join the BRICS as of 2024," Lula wrote in a post published on his X (formerly known as X) page, after a summit of the bloc in Johannes-

"Iran was the largest importer of Brazilian products in the Middle East in 2022, having imported almost \$4.3 billion worth of commodities, and should continue to be an important commercial partner for Brazil in the coming years."

Brazil is a major trade partner for Iran. Its exports to Iran include animal feed and meat, among other products, while imports mostly cover fertilizers, including urea supplied by Iranian petrochemical companies.

Iran hopes to double its trade with Brazil within a few years to reach an annual target of \$10 billion, Fakhreddin Amerian, who chairs Iran's trade center in Brazil and heads the Iran-Brazil Joint Chamber of Commerce (IBJCC), said in early June.

Raisi and his Brazilian counterpart met on the sidelines of the 15th meeting of the BRICS group of emerging economies in South Africa's largest city of Johannes-

The Iranian president congratulated Lula on his re-election, expressing satisfaction over the enhancement of bilateral relations between Iran and Brazil.

Raisi said U.S. officials have acknowledged that Washington's so-called campaign of "maximum pressure" against Iran has failed to achieve its goals, emphasizing

that the Islamic Republic has managed to make advances in science and technology regardless of cruel sanctions.

Lula, for his part, felicitated Iran on its induction into BRICS, stressing that there exist abundant opportunities such as scientific exchanges, technology, academic expertise and cultural issues for member states to expand cooperation and relations.

The Brazilian president described sanctions as "a criminal weapon against nations," stating that they affect the people of the targeted countries.

Lula also criticized the current structure of the United Nations, saying it is incapable of preventing the violations of other nations' rights by certain powers.

He underscored that the present-day structures need to be redesigned, saying BRICS should be able to introduce (Continued on Page 7)

Minister: 1,531 Prisoners Exchanged With Countries

TEHRAN – Iranian Minister of Justice Amin Hussein Rahimi said Saturday that a total of 1,531 prisoners have been exchanged between Iran and other

Since President Raisi's administration began in August 2021, 14 bilateral documents have been signed prisoners were extradited, Rahimi told

Rahimi said that 298 Iranian prisoners have been returned to Iran from other countries since last year, adding

that 1,233 foreign nationals imprisoned in Iran were transferred to their own countries within the framework of bilateral agreements.

He also said 105 Iranian prisoners were transferred to Iran through the efforts of the ministry of justice and the ministry of foreign affairs. Among with nine countries, and 1,531 Iranian them were one prisoner suffering from an incurable disease from China, 16 handed over to their country based prisoners from Tanzania, 15 prisoners from the Iraqi Kurdistan Region, 19 prisoners from Qatar, and one prisoner from Thailand. These prisoners

were arrested and sentenced to longterm imprisonment for carrying narcotics and prohibited drugs.

Rahimi also stated that 28 Iranian prisoners in Kuwait and two Iranian convicts in India were transferred to Iran with the cooperation of the consulates of Iran in Kuwait and India.

He said 279 Afghan prisoners were on an agreement on the transfer of convicts so far this year, adding that last year, 800 Afghan prisoners were transferred to their country

Three Main Terrorists in Shah Cheragh **Attack Indicted**

TEHRAN -- Iran's judiciary has brought criminal indictments against the three main terrorists involved in the recent deadly terrorist attack on the Shah Cheragh shrine in Iran's southern city of Shiraz.

Kazem Mousavi, head of the Fars province justice department, said on Saturday the trio

will be soon put on trial.

He said the primary culprit of the terror attack, identified as Rahmatullah Nowruz, is accused of membership in the Daesh terrorist group, as well as militancy

lah Arabzadeh and Amrollah

Nazari, are also accused of partnership in "corruption on earth" and collusion with Daesh in order to undermine Iran's national security, he added Mousavi explained that a num-

ber of individuals arrested in connection with the attack have been released after they were found innocent, after which nonsuit orders have been issued for them.

Investigation is still ongoing with regard to a several other

suspects, he added. The senior Iranian judiciary official noted that investigation into all circumstances of the ter-

rorist attack on the Shah Cheragh

shrine will continue with rapt at-

tention, and all individuals who collaborated with the primary culprits will be brought to jus-

Two people were martyred and eight others injured in an armed terrorist attack on the Shah Cheragh shrine on August 13, for which Daesh later claimed responsibility.

The Shah Cheragh shrine was the scene of a similar attack by armed terrorists on October 26, 2022, when an armed terrorist barged into the shrine, martyring 13 pilgrims, including women and children, and injuring dozens more before he was shot and injured by security forces.

Ministry: Europeans Want to **Buy Iranian Drones**

TEHRAN – A number of European countries have asked to purchase Iran's unmanned aerial vehicles, the spokesperson for the Iranian defense ministry said Saturday.

Speaking to Tasnim, Brigadier General Reza Talaee Nik said Iranian-made military drones have a lot of potential

Many countries, including a number of Western and European states, have demanded to purchase Iranian drones, the spokesman said, adding that the applicants wish to remain anonymous.

The spokesman noted that Iran is prepared to export military drones after fulfilling its domestic needs, provided that "political and security considerations" do not apply to the customer and Iran makes sure that its drones won't be intend-

ed for inappropriate utility. Last week, the chief of Staff of the Iranian armed forces said the country has developed such advanced defense products that the big military powers of the world are willing to acquire its achievements.

Tasnim Photojournalist Handed Over to **Embassy in Kabul**

TEHRAN -- An Iranian photojournalist recently taken into custody by the Taliban-run government in Afghanistan has been released and handed over to officials at the Iranian embassy in Kabul.

Taliban deputy spokesman Bilal Karimi confirmed on Saturday the release of Muhammad Hussein Velayati of Tehran-based Tasnim news agency, but he is reportedly still banned from leaving the em-

Velayati legally entered Afghanistan through the air border and stayed in Kabul for 10 days. He was arrested at Kabul International Airport in the Afghan capital shortly before boarding a return flight home last Saturday.
