# **Report: Nearly 650 Athletes** Martyred in Gaza Since Last Oct.

GAZA (Dispatches) - The Palestinian Football Association has reported that at least 644 athletes, including nearly 400 football players have been killed by Zionist troops in Gaza since October

It added that at least 91 of them are children. They are among the 45,206 Palestinians killed by Zionist troops in Gaza since October 2023.

Israel's October-present genocidal war on the Gaza Strip left its impact on football, the most popular sport in Palestine. The war has also forced the Palestinian men's football team to play its matches away from home.

In May, the Palestinian Football Association (PFA) presented arguments accusing the Israel Football Association (IFA) of violating FIFA statutes with its war on the besieged enclave and its inclusion of teams located in illegal settlements on Palestinian territory in its domestic league.

The PFA wanted FIFA to adopt "appropriate sanctions" against the Zionist regime and its teams, including an international ban.

The IFA termed the request a will review the allegations of dis-"cynical political move".

FIFA had passed the issue to independent legal advisers who carried out an evaluation and compiled a response.

FIFA has repeatedly postponed a decision on the Palestinian call to ban the Zionist regime from football amid its ongoing war on

## **Zionist Settlers Establish New Illegal Outpost Near Ariha**

WEST BANK (Dispatches) Zionist settlers established on Saturday a new illegal outpost near the Palestinian Bedouin community along the al-Ma'arajat Road, based northwest of Ariha city in the eastern occupied West Bank.

Hassan Mleihat, the general supervisor of the local al-Baidar Organization for Defending Bedouin Rights, told Wafa news agency that settlers set up a tent on the community's land early this morning and performed provocative dances in the area.

He also noted the presence of five settler outposts near the al-Ma'arajat Road, with four established since October 7, 2023.

These outposts are part of ongoing efforts to expand settlers' control over the border areas between the Ramallah and Ariha governorates.

Israeli estimates indicate that more than 720,000 Zionists now live in illegal settlement outposts in the occupied West Bank, including East Al-Quds. Settlement construction has accelerated significantly since the Zionist regime's right-wing cabinet, led by prime minister Benjamin Netanyahu, came to power in Decem-

The international community, including the UN, considers these settlements illegal under international law. The UN has repeatedly warned that continued settlement expansion threatens the viability of a so-called "two-state solution," a framework sought to pass off as key to resolving the Zionist-Palestinian conflict.

In a significant legal development in July, the International Court of Justice (ICJ) issued a ruling that declared the Zionist regime's decades-long occupation of Palestinian territories "illegal". The court called for the immediate evacuation of all existing settlements in the occupied West Bank and East Al-Ouds.

Despite global condemnation and calls for a halt to settlement activity, the regime continues its expansion efforts, deepening tensions in the region.

### U.S. Judge Finds Israel's NSO Liable for Hacking in WhatsApp Lawsuit

WASHINGTON (Dispatches) -A U.S. judge has ruled in favor of WhatsApp in a lawsuit accusing the Zionist regime's NSO Group of exploiting a bug in the messaging app to install spy software allowing un-

authorized surveillance. U.S. District Judge Phyllis Hamilton in Oakland, California, found NSO liable for hacking and breach of contract.

The case will now proceed to a trial only on the issue of damages, Hamilton said.

Will Cathcart, the head of WhatsApp, said: "We spent five years presenting our case because we firmly believe that spyware companies could not hide behind immunity or avoid accountability for

their unlawful actions. "Surveillance companies should be on notice that illegal spying will not be tolerated."

WhatsApp in 2019 sued NSO, accusing it of accessing WhatsApp servers without permission to install the Pegasus software on victims' mobile devices.

The lawsuit alleged the intru-

sion allowed the surveillance of 1,400 people, including journalists, human rights activists and dissidents.

NSO had claimed that Pegasus helps law enforcement and intelligence agencies fight crime and that its technology is intended to help catch terrorists, pedophiles and hardened criminals.

# WHO: Lebanon Facing 'Staggering' Unmet Health Needs

BEIRUT (Dispatches) - Lebanon is facing "staggering unmet health needs" as thousands of civilians cry out for reconstructive surgeries and physical rehabilitation after the ceasefire between the Zionist regime and Hezbollah resistance movement, the World Health Organization Lebanon Office says.

Over 4,000 people have been killed and 17,000 others injured in Lebanon since last October, and the death toll has been climbing continuously "as more bodies are found in the 16,000 buildings that have been partially or completely destroyed, leaving an estimated 8 million tons of debris," the office said in a news release.

"One in four people with life-changing injuries will need long-term rehabilitation," it

Most hospitals in Lebanon are running below capacity due to financial restraints and shortages of health workers, long-standing challenges in Lebanon, it said.

The need for health workers is also dire in the country, as more than 530 health workers and patients have been killed or wounded in attacks on health care, and thousands of health workers have been displaced, it said.

"Water and sanitation systems have been severely disrupted, compounding the risk of disease outbreaks," it added.

The ceasefire agreement between the Zionist regime and Hezbollah went into effect on Nov. 27, putting an end to the confrontations that erupted on Oct. 8, 2023. Despite the agreement, the occupying re-

gime's army continues to carry out strikes in

Lebanon, which, according to reports from

official Lebanese media, ranged between machine gun fire, artillery shelling, bulldozing homes, and airstrikes, some of which resulted in deaths and injuries in southern and eastern Lebanon. Meanwhile, Hezbollah has violated the truce once after it said it was in response to the repeated Israeli at-
