# Report: Iran World's 7th Largest Crude Oil Producer in 2023



TEHRAN – Iran was the 7th largest crude oil producer in the world in 2023, according to the British IE Institute.

Iran also ranked second in the world in terms of rise in production, registering a 19-percent growth in production of crude oil and condensates last year, the institute added.

In its report on the review of global energy, the IE Institute said Iran ranked second in terms of increasing the volume of its crude oil production in 2023.

Despite the cruel and unilateral

According to this report, Iran accounted for 4.8 percent of the world's total crude oil and gas condensates production in 2023.

The Vortexa website also reported Iran has overtaken Kuwait and Nigeria to be the fourth largest crude/ condensate exporter of OPEC.

Iran's crude/condensate exports accounted for 9% of OPEC's crude/ condensate exports in February 2024 and again in May 2024, the highest share since August 2018,.

Rising crude exports mean Iran has overtaken Kuwait and Nigeria to be the fourth largest crude/condensate exporter in OPEC. Iran's crude exports averaged 1.56mbd across January-May this year, around 250kbd higher than both Kuwait and Nigeria. Despite ongoing sanctions, Iran managed to increase its crude/condensate exports to 1.7mbd in May, the highest levels observed in more than five years.

Referring to the reasons behind Iran's success, the website announced that an increase in Iran's crude production, higher demand from China, and a net increase in the size of its dark fleet, have helped the country to increase its exports.

### Iran to Establish 16 Pharmaceutical Factories Overseas

TEHRAN – The chairman of the Board of Directors of the Iranian Syndicate of Pharmaceutical, Chemical and Pharmaceutical Packaging Manufacturers Faramrz Ekhteraei has said negotiations are ongoing with foreign countries for the construction of factories abroad to produce pharmaceuticals.

Ekhteraei said that the pharmaceutical industry of the country has taken giant strides since the glorious victory of the Islamic Revolution of Iran. He termed the 'generics plan' as an achievement in the pharmaceutical industry of the country and said this comprehensive plan, in addition to controlling the price of the medicine, managed to achieve achievements in making pharmaceutical components.

Ekhteraei went on to say that more than 70 percent of the raw materials needed in the pharmaceutical industry are currently supplied by domestic companies. Elsewhere in his remarks, he pointed to the capabilities and potentials of the pharmaceutical industry of the country in the export of pharmaceuticals and said the sanctions imposed against the country have created problems in the way of export of pharmaceuticals abroad.

Construction of factories producing raw materials of pharmaceuticals by the Iranian companies in other countries indicates the capability and potential of the pharmaceutical industry of the country in the international arenas, Ekhteraei added.

#### U.S. Sanctions Boeing for Leaking Info on Door-Plug Investigation

SAN FRANCISCO (Business-Standard) - The U.S. National Transportation Safety Board announced sanctions against Boeing after the company "blatantly violated" regulations by revealing non-public investigative information about a door-plug blowout incident on a passenger jet in January.

During a media briefing Tuesday, a Boeing executive provided investigative information about the incident involving a Boeing 737 Max 9 of Alaska Airlines and gave an analysis of factual information previously released.

The NTSB said both of these



NTSB produces as it develops the factual record of the accident, it said. The NTSB said it may subpoena any relevant records it requires during the course of the investigation. It will also subpoena the company to appear at an investigative hearing into the case scheduled for Aug 6-7 in Washington, DC. "Unlike the other parties in the hearing, Boeing will not be allowed to ask questions of other participants." After the NTSB learned of the unauthorized release of information and requested additional information about the press brief-

ellers "with limited re-accommodation options available" — just hours after the airline's mechanics said they would strike.

"Additional cancellations were anticipated by Saturday morning, the company said in a release issued just after midnight in Calgary, where the airline is based. "WestJet is actively and aggressively pursuing every avenue to minimize disruption, including asking for immediate intervention by the minister of labor." WestJet mechanics decided to strike one day after Labor Minister Seamus O'Regan directed the Canada Industrial Relations Board (CIRB) to impose binding arbitration to solve outstanding issues of the collective agreement between the airline and Aircraft Mechanics Fraternal Association (AMFA). In a statement Thursday, AMFA said there is no modern precedent for the minister's action. The order also followed two weeks of turbulent discussions with the union on a new deal.



AMFA said on Friday that roughly 680 workers went ahead

with strike action against the company, but the union remains engaged in dialogue with the CIRB to resolve the impasse.

"The aircraft maintenance engineers were hopeful this action would be unnecessary but the airline's unwillingness to negotiate with the union made the strike," the statement reads.

The union said it will comply with the arbitration process, and directed its members to avoid any unlawful job action.

The union's legal counsel said the strike is within the union's rights even with the minister's order. Sam Seham said there was no explicit mention that job action by AMFA would be against the law. actions are prohibited by the party agreement that Boeing signed when it was offered party status by the NTSB at the start of the investigation. "As a party to many NTSB investigations over the past decades, few entities know the rules better than Boeing," the agency said in a statement.

Boeing will retain its party status, but no longer have access to the investigative information the ing, Boeing provided the agency with a transcript.

In the briefing, Boeing portrayed the NTSB investigation as a search to locate the individual responsible for the door plug work. The NTSB is instead focused on the probable cause of the accident, not placing blame on any individual or assessing liability, according to its statement.

#### Oil Steady Below Two-Month High as Traders Weigh Mixed Outlook

LONODN (Bloomberg) -- Oil settled little changed after retreating from a nearly two-month high as traders weighed a swelling supplies against escalating Mideast tensions.

West Texas Intermediate crude fell 0.2% to near \$81 a barrel. Oil remains locked in a narrow range as markets show rising U.S. supplies and China's economy appears sluggish. Still, crude ended the month nearly 6% higher.

China's economic outlook is a major factor weighing on the market. A demand slowdown in the world's biggest crude importer has forced refiners to cut operating rates and prolong maintenance.

The U.S. outlook is more sanguine. The Federal Reserve's preferred measure of underlying U.S. inflation decelerated in May, bolstering the case for lower interest rates later this year. Federal Reserve Bank of Atlanta President Raphael Bostic said he continues to expect one interest rate cut this year in the fourth quarter as inflation shows progress.

Prompt spreads are signaling some strength, with the measure for Brent rallying as high as \$1.69 a barrel in a bullish backwardation structure ahead of the contract expiry.
