UN Urges Independent Probe Into Gaza Aid Ship Attack

GENEVA (Dispatches) - The UN human rights office on Saturday called for an independent investigation into the drone attack on a Gaza-bound aid ship in international waters off Malta and renewed its call for the Zionist regime to lift its blockade on Gaza, which it says constitutes "collective punishment."

"We have seen the worrying reports on the incident. We are unable to independently confirm them. However, it is crucial that there be independent, impartial, and effective investigation by competent authorities into the incident leading to apparent fire on board the vessel and a distress call in international waters, with a view to ensuring accountability," human rights spokesperson Thameen al-Kheetan told Anadolu in a statement.

The vessel Conscience, organized by the Freedom Flotilla Coalition, caught fire after being bombed by drones early Friday while carrying humanitarian aid to Gaza. The Maltese government confirmed the fire was contained with the help of a nearby tugboat

Gaza Freedom Flotilla was hit by Israeli drone on 1 May 2025.

The vessel remains in international waters under monitoring.

Prosecutors said Shaheen called police in 2023 after Czuba forced his way into her bedroom and stabbed her repeatedly. She was able to lock herself in a bathroom to call for help, during which time Czuba attacked her child.

"The cruelty of this morally

reprehensible killer and the impact of his violent conduct on this innocent child and mother is truly unfathomable," prosecutor James Glasgow said in a statement.

Jurors deliberated for just over an hour before finding Czuba guilty of first-degree murder, attempted murder and two counts of a hate crime.

Judge Amy Bertani-Tomczak sentenced Czuba to 30 years in prison for Wadea's murder, 20 years for the attack on his mother and three years for the hate crimes, to be served con-

secutively, the Chicago Sun Times reported.

During sentencing, the boy's great-uncle Mahmoud Yousef asked Czuba why he did it but received no response, the newspaper said.

"We want to know what made him do this," Yousef told the

According to the Will County Sheriff's Office, the victims were targeted "due to them being Muslim and the ongoing Middle Eastern conflict involving Hamas and the Israelis."

U.S. House Set to Vote on Bill of Fines, Prison for Boycott of Israel

WASHINGTON (Dispatches) -The U.S. House of Representatives is set to vote on a controversial bill that proposes fines or prison terms for Americans participating in boycotts of Israel or Israeli settlements, promoted by international governmental organizations such as the UN

The House is scheduled to vote Monday on the contentious anuboycott act, which seeks to penalize American citizens with fines up to \$1 million or prison terms as long as 20 years for boycotting the Israeli regime.

Sponsored by pro-Israel congressmen Mike Lawler and Josh Gottheimer, the bill will broaden the U.S. anti-boycott law by targeting voluntary, values-based political actions undertaken by American

The underlying objective is to shield the Zionist regime from non-violent international pressure campaigns, notably the Boycott, Divestment, and Sanctions movement (BDS).

Rights groups warned that the legislation will criminalize constitutionally protected political ex-

The move, according to rights groups, is part of a broader push by the U.S. government to suppress opposition to Israeli genocide, apartheid, and illegal settlement ex-

pansion, under the guise of fighting anti-Semitism.

The original act was introduced in 2024. Back then the Republicancontrolled Congress passed this bill with broad bipartisan support, but the Senate Democrats blocked the

Now that Republicans control the Senate as well, there is a significant chance that the act will pass both Congress and Senate.

The American Israel Public Affairs Committee (AIPAC), the most powerful Israeli lobby group in the U.S., said it "strongly supports" the

The Foundation for Defense of Democracies (FDD) Action has already supported the legislation and broader congressional campaigns to push back against anti-Israeli bovcotts.

The majority of anti-Israeli boycotts aim to force the regime to end its genocidal war on Gaza that has taken the lives of more than 52,500 Palestinians and injured at least 118,000, most of whom are children and women.

The Israeli regime has put Gaza on a total blockade for 2 months and barred the entry of all humanitarian aid, including food, which according to the UN's Integrated Food Security Phase Classification (IPC), has driven the territory's 2.3 million population toward famine.

Journalist Group Demands End to Zionist Crimes Against Media Workers in Gaza, West Bank

WEST BANK (Dispatches) - The Palestinian Journalists' Syndicate has demanded ending the Zionist regime's systematic targeting of journalists in the Gaza Strip and the occupied West Bank, urging immediate international action to protect media freedom, Anadolu reports.

The group accused the occupying regime of carrying out "the most horrific media genocide in history" against Palestinian journalists in a statement to mark World Press Freedom Day, observed annually on May 3.

The syndicate reported that 210 Palestinian journalists have been killed in the last 17 months of the Israeli genocidal war on Gaza, with hundreds wounded or losing family members, along with the destruction of media facilities and thousands of violations against media workers in the West Bank. "Currently, 55 journalists remain detained

in Israeli prisons out of 177 arrested since Oct. 7, 2023," according to the statement.

The journalist body demanded the immediate release of all imprisoned journalists and international action to hold Zionist regime officials accountable for crimes against me-

"The world celebrates press freedom while Palestine endures unprecedented attacks on journalism," it read.

World Press Freedom Day was established by a UN General Assembly resolution in December 1993 to defend media independence worldwide.

This year's commemoration comes amid what media freedom organizations describe as the deadliest period for journalists in modern history, with Palestinian reporters bearing the brunt of the casualties. The occupying regime army renewed its

assault on Gaza on March 18, shattering a Jan. 19 ceasefire and prisoner exchange agreement with the Palestinian resistance group, Hamas.

More than 52,000 Palestinians have been killed in Gaza in a brutal Israeli onslaught since October 2023, most of them women and children.
