## **Envoy to UN: Israeli Aggression** on Syria 'Dangerous Escalation'

NEW YORK (Dispatches) -Iran's Ambassador to the United Nations Amir Saeid Iravani strongly condemned Israel's recent military attacks on Syria during a Security Council session on Thursday, calling the actions a "dangerous escalation" and a violation of international law.

"These deliberate acts of aggression, including those on the capital, Damascus, targeted infrastructures and public and government facilities," Iravani said. He criticized Israel's ongoing occupation of the Syrian Golan Heights, calling it an "illegal annexation and settlement expansion" that defies the UN Charter and Security Council resolutions.

Iran's envoy described Israel as "the gravest and serious threat to regional peace and security," citing its "continued acts of aggression" supported politically and militarily by the United States and some Western countries. "These states must bear their responsibility for enabling Israel's illegal actions and atrocious crimes," he said.

Iravani linked Israel's attacks on Syria to the Security Council's "silence and the international community's failure to act," warning that Israel "faces no consequences for its repeated systematic violations of international law and continues to act with complete impunity."

He condemned Israel's recent 12-day military aggression against Iran, which included attacks on nuclear facilities and civilian infrastructure. "These illegal attacks resulted in the martyrdom of over 1,100 civilians, among them 41 children and 126 women," Iravani said. "Seven hospitals, eleven ambulances, and more than 3,500 homes were destroyed."

"The root causes of instability are clear: Israel's illegal occupation, repeated aggression, systematic and widespread violations of international law and the UN Charter, and the unconditional support it receives from a permanent member of this Council," he added. "It is time for the Security Council to

Iravani also condemned the humanitarian crisis in Gaza, describing Israel's tactics as "mass atrocities... using starvation as a method of war and killing tens of thousands of civilians, including women and children.'

He reaffirmed Iran's support for Syria's "sovereignty, unity, and territorial integrity," urging Syria's interim government to respect minority rights through peaceful dia-

"The Israeli regime has absolutely no legal or moral justification to violate Syria's sovereignty or interfere in its internal affairs," he said, urging the Council to "unequivocally condemn" Israel's ac-

## **Iran: Argentina's Accusations** on AMIA Anniversary 'Baseless'

TEHRAN – Iran has dismissed as "baseless" accusations against its nationals over the 1994 bombing of the Argentine Israelite Mutual Association (AMIA) in Buenos Aires, urging Argentine judicial authorities to conduct a transparent and fair investigation free from outside influence.

In a statement marking the 31st anniversary of the attack, which killed 85 people and injured over 300, Iran's Foreign Ministry said elements linked to Israel are exploiting the bombing to derail Iran-Argentina relations and steer the case "into a misleading and incorrect path."

"Completely rejecting the accusations against its citizens, the Islamic Republic condemns attempts by certain domestic circles in Argentina to pressure the judiciary into issuing baseless charges against Iranian nationals," the ministry said.

The statement also pointed to evidence of Israeli influence on the Argentine judicial process, citing frequent changes in investigators, judicial corruption, judge resignations, and even attempts on judges' lives as signs of efforts to undermine a fair

Iran noted that bilateral efforts, including a 2013 memorandum of understanding aimed at clarifying the case, were later unilaterally canceled by Buenos Aires, obstructing a transparent investigation.

"The Islamic Republic insists on restoring the dignity of the accused citizens and demands an end to the politicization of the case," the statement added. Iran further reserved the right to respond "in accordance with international law" to any unjust actions against itself or its citi-

# Judiciary Chief Urges Swift Justice in Israeli-Related Cases

TEHRAN - Iran's Judiciary Chief, Gholamhussein Mohseni-Eje'i, has called for the rapid and precise handling of all judicial cases involving individuals accused of ties to Israel's regime, following a series of unprovoked Israeli attacks target-

"Accelerating the investigation and resolution of cases involving individuals suspected of links to the Zionist regime is an undeniable necessity," Mohseni-Eje'i told judiciary officials. "There must be no delay or negligence in this matter."

The call comes after Israel's military launched strikes starting June 13 against Iranian military commanders, nuclear scientists, and civilians. The United States also conducted air raids on three Iranian nuclear facilities, escalating tensions further.

Iranian security forces have dismantled multiple sabotage cells linked to Israel's spy agency, Mossad, seizing Israeli-made Spike anti-tank missiles, suicide drones, and explosives. Operations targeting drone workshops and bombmaking sites have been conducted in Tehran, Isfahan, Alborz, Mazandaran, and other provinces.

Authorities say these planned attacks on critical infrastructure and residential areas. Iranian officials accuse Mossad of trating assassinations, and conducting espionage inside Iran.

Mohseni-Eje'i described the recent aggression as a multilayered conspiracy by the enemy to destabilize Iran but said, "the awareness and loyalty of the people neutralized the plots at the outset."

He noted, "The enemy deliberately targeted key centers hoping to spark unrest and chaos, but in reality, people from different classes and political views-all emphasizing adherence to the leadership—helped preserve the Islamic Republic. As a result, the enemy's conspiracy did not come to frui-

Highlighting national Mohseni-Eje'i said, "We today face the most hostile enemies of God and humanity. This is both difficult and sweet; humiliating these malicious enemies will bring us a special satisfaction."

He credited the leadership of Ayatollah Seyyed Ali Khamenei, Iran's military and security forces, and the nation's unity for thwarting the adversaries' objectives.

"Thanks to the leadership of the Eminent Leader, the military and security power of the country, and the outstanding unity and cohesion of the people, the enemies of the Islamic Republic, led by the Zionist funding terrorist groups, orchesto achieve any of their goals," he handled without delay."

said. "On the contrary, the power of the system and the Iranian nation increased."

Ayatollah Khamenei on Wednesday urged the judiciary to vigorously pursue those responsible for the attacks both inside and outside

Mohseni-Eje'i emphasized that despite the heightened security environment, "under no circumstances should we deviate from justice, fairness, and legal principles."

He added, "Indictments in such cases must be prepared with maximum comprehensiveness, supported with documented and well-reasoned evidence before being submitted to the courts. The courts, in turn, must issue fair verdicts based on the law, with the utmost speed and precision, for those whose guilt is proven."

Since June 13, Iranian security forces have arrested dozens on suspicion of ties to Israel. Mohseni-Eje'i noted that some cases may predate the recent aggression and could span various judicial branch-

"Determining the outcome of such cases—especially those that may fall under the category of corruption on earth—is a top priority," he said. "Other related cases, even if they do not qualify as espionage regime and the United States, failed or corruption on earth, must also be

# U.S. Claims About Ex-FBI Agent's Disappearance 'Misleading'

TEHRAN – Iran's Foreign Ministry has dismissed renewed U.S. allegations implicating Iranian nationals in the disappearance of former FBI agent Robert Levinson nearly 18 years ago, calling the claims unfounded and mis-

Ministry spokesman Esmaeil Baghaei said that despite repeated accusations, U.S. officials have failed to provide credible evidence that Levinson ever entered Iranian territory or that any incident related to him occurred in Iran. "These are mere reiterations of previous baseless allega-

ton's accusations as an attempt to avoid accountability before its own public. He rejected any Iranian involvement or knowledge of Levinson's disappearance, condemning the targeting and sanctioning of Iranian citizens in connection with the case as "arbitrary, illegal, and unjustified," violating international law and human rights norms.

"The U.S. government must be held responsible for such unlawful actions," Baghaei added.

Levinson went missing in March 2007 after reportedly

unknown despite years of investigations and efforts to secure his

Initially described by U.S. authorities as a private investigator, Levinson's family later revealed in 2013 that he was working covertly for the CIA. Over the years, videos and images purportedly of Levinson have been sent to his family, seeking help for his release.

In 2016, the White House stated it had reason to believe Levinson was no longer in Iran. The FBI has offered a \$5 million reward for information leading to his safe return.

## 'Deceitful': Iran Rejects U.S. Claim of **Arms Supply** to Yemen

TEHRAN – Iran has strongly rejected renewed U.S. allegations that it supplies military equipment to Yemen, calling the claims "unfounded" and part of Washington's ongoing media campaign aimed at diverting attention from Israel's aggressive actions in the region.

Foreign Ministry spokesman Esmaeil Baghaei condemned the U.S. accusations on Thursday, saying they were "a deceitful attempt to shift focus away from the Israeli regime's relentless warmongering and crimes against regional nations."

Baghaei held the United States responsible for enabling Israel's escalation of violence in Gaza, the occupied West Bank, and neighboring countries. "The U.S. government provides political and military support that allows Israel to carry out its genocidal campaign while violating the sovereignty and territorial integrity of Syria and Lebanon," he said.

Baghaei emphasized that the United States uses accusations against Iran as a pretext to justify its military presence and destabilizing actions in the region. "Washington is attempting to legitimize its partnership with Israel and distract from the root causes of instability," he added.

Iranian officials further stressed that Israel's aggression is not limited to Palestine but extends to Yemen, Syria, Lebanon, and Iran itself, warning of the dangerous consequences of continued foreign interference.

"The successful retaliatory operations by Iran have effectively halted the illegal assaults launched by Israel and the US," Baghaei said, underscoring Tehran's commitment to defending regional sovereignty and security.
