Capital Punishment the **Only Solution**

If the US had justice and respect for humanitarian values, a liar and a fraudster, such as Donald Trump, would never have become

When, however, elected as Chief Executive - mainly because of fraudulent voting – he deserved a kick out of the White House, especially after his criminal breach of the 5+1 international nuclear accord with Iran.

Kayham Envoy Reports Trump's 'Criminal Confession' to Security Council

UNITED NATIONS (Dispatches) Iran's Ambassador and Permanent Representative to the United Nations Amir Saeid Iravani has condemned U.S. President Donald Trump's remarks acknowledging Washington's involvement in Israel's military attacks against Iran, describing them as "a criminal confession" that exposes U.S. responsibility for what Tehran calls acts of aggression.

In a letter to UN Secretary-General Antonio Guterres and Security Council President Michael Imran Kanu, Iravani said Trump's statements amounted to clear evidence of the United States' "direct involvement, leadership, and command responsibility" in the Israeli strikes carried out between June 13 and 24, 2025.

"On Thursday, 6 November 2025, President Donald J. Trump told reporters: 'Israel attacked first. That attack was very, very powerful. I was very much in charge of that," Iravani wrote. He added that Trump further said, "When Israel attacked Iran first, that was a great day for Israel because that attack did more damage than the rest of them put together.""

The Iranian envoy said the U.S. president's remarks "constitute clear and irrefutable evidence" that Washington orchestrated, directed, and enabled what Tehran considers an unlawful use of force by Israel.

The strikes, he added, caused numerous civilian casualties, widespread damage to civilian infrastructure, and serious harm to "Iran's safeguarded and peaceful nuclear facilities.'

"These criminal aggressions," Iravani wrote, "represent a grave and flagrant violation of Article 2 (4) of the Charter of the United Nations, the peremptory norms prohibiting the threat or use of force against sovereign States, and international humanitarian law."

The Iranian representative said Trump's statement also exposed contradictions in earlier remarks by U.S. Secretary of State Marko Rubio, who had denied American involvement in the hostilities.

"This explicit admission by the President of the United States ... clearly and unequivocally exposes the falsity of the earlier statement made by the United States Secretary of State on 13 June 2025," Iravani wrote, referring to Rubio's assertion that Washington's "top priority is protecting American forces in the region."

Iravani said the admission establishes the United States' "international responsibility and culpability" alongside Israel, making both parties "fully and jointly responsible" for the attacks and their consequences. He said the aggression led to "the loss of innocent lives, extensive destruction of civilian property and infrastructure, and the deliberate targeting" of Iran's nuclear facilities.

The ambassador reiterated Iran's right "to pursue all available international legal avenues" to ensure accountability, seek reparations, and obtain compensation "for all those lost their lives as well as for injuries, damages, and losses inflicted upon the Islamic Republic of Iran and its

He asked the UN to circulate the letter as an official document of the Security Council.

Mexico, Iran Deny Israeli Claim of Plot Targeting Its Diplomat

MEXICO CITY (Dispatches) -Iran's embassy in Mexico has rejected as a "big lie" claims by the United States and Israel that Tehran plotted to assassinate Israel's ambassador to Mexico, calling the allegation a fabricated attempt to damage relations between Iran and

"The accusation about an alleged attempt by Iran to assassinate the ambassador of the Israeli regime in Mexico is a media fabrication, a big lie, whose objective is to

damage the friendly and historical relations between both countries (Mexico and Iran), which we categorically reject," the embassy said in a post on X.

Israeli officials have claimed that ambassador, Einat Kranz Neiger.

Iran's embassy dismissed the accusation, saying, "Iran and Mexico share identical interests. Mexico's security and reputation are also Iran's security and reputation. We

will never betray the trust the Mexican government has placed in us."

The mission added that the report was part of a broader campaign to undermine Tehran's international ties. "This is not the first time they Mexican authorities intervened to have tried to damage Iran's relafoil an alleged plot to target Israel's tions with other countries through fake news," it said.

Senior Iranian Diplomat at Sasakawa Peace Foundation in Tokyo:

12-Day War a 'Real Laboratory' That **Shattered Anti-Iran Myths**

TEHRAN - Iran's Deputy Foreign Minister and head of the Institute for Political and International Studies (IPIS) Saeed Khatibzadeh has said that the recent 12-day war between Israel and Iran served as a "real laboratory" moted for years against Tehran.

exposing "flawed narratives" pro-Speaking at the Sasakawa Peace Foundation in Tokyo during a seminar titled "The 12-Day War and Regional Outlook: Iran's View on Peaceful Cooperation,"

Khatibzadeh denounced Israel's recent strikes on Iran as a "blatant violation of international law." "Despite the absence of any

evidence of nuclear weapons or deviation in Iran's peaceful nuclear program, and while diplomacy and negotiations were ongoing, one must ask why Israel, in close cooperation with the United States, carried out this attack," he said. "The answer to this question clearly determines how countries should respond to such acts of aggression."

Analyzing the broader motives behind Israel's actions, Khatibzadeh said the Zionist regime, driven by "geopolitical delusions and expansionist ambitions," seeks to create "strategic depth,

expand its borders, and establish

dominance over the entire West Asia region."

He urged regional countries and the international community to take steps to halt Israel's "series of aggressions."

"The aggressive 12-day war was a real laboratory to test many of the flawed propositions that the Israeli regime and Iranophobes had sold to public opinion through mainstream media for years," Khatibzadeh said. "The invalidation of these narratives occurred only through the brave national defense of Iran and the unprecedented unity of its people."

FM Araghchi Blasts Netanyahu's 'Anchor of Security' Bluff

TEHRAN - Iranian Foreign Minister Abbas Araghchi rejected Zionist leader Benjamin Netanyahu's claim that Israel serves as an "anchor of security" in the Middle East, saying instead that the illegal entity is responsible for instability and conflict across the region.

In a post on X, Araghchi wrote: "The so-called 'anchor of security in the Middle East' is wanted for genocide and war crimes, has imposed apartheid on 7.5 million Palestinians, bombed seven countries over the past year, and has occupied Palestinian, Lebanese and Syrian territory."

He added, "Israel is the source of instability in our region."

Araghchi's comments followed Netanyahu's remarks earlier in the week in which the Zionist leader described Israel as a stabilizing force amid regional turmoil.

The Iranian minister's post comes as Israel's war on Gaza, launched on October 7, 2023, has killed nearly 70,000 Palestinians, according to figures cited by Iranian officials. A ceasefire deal was reached last month after months of a genocidal campaign.

In May, the International Criminal Court (ICC) issued arrest warrants for Netanyahu and former Israeli war minister Yoav Gallant on charges of war crimes and crimes against humanity over the conduct of the Gaza war.

Since the outbreak of the genocidal war on Gaza, Israel has expanded its military aggression to several countries in the region. It has carried out airstrikes in Lebanon, Syria, Tunisia, and Yemen, and launched what it described as a targeted attack on Hamas figures in Qatar, which killed several members of the Palestinian movement and a Qatari security officer.

Tensions further escalated in June when Israel launched an unprovoked aggression against Iran on June 13, martyring senior Iranian commanders, nuclear scientists, and civilians.

The United States subsequently joined the war by striking three Iranian nuclear facilities in a grave violation of the UN Charter, international law, and the Nuclear Non-Proliferation Treaty (NPT).

Iran launched retaliatory operations against both Israel and the United States on June 24, forcing an end to the illegal aggression.
